## **Reports:**

**Fire Department:** Fire Chief Brian O'Connor presented the fire department report to the council. Brian reported there have been 45 call outs to date. The burn pile is closed awaiting colder weather before we can burn the pile. The new fire hose has arrived. The Rock River Fireman's Ball is this coming weekend. The firefighters who had attended the EMR class all passed.

**SCWEMS:** Mayor Irene presented the SCWEMS report to the council. Elections for officers were held at the last SCWEMS meeting. The new ambulance is stationed in Hanna and due to the grant stipulation, the ambulance will remain in Hanna.

**Public Works Department:** Will Redmond, the public works director, presented the public works report to the council. Will reported that the garbage truck, water treatment plant and the lagoon are all running well. The pothole project has been finished. We received the sanitary survey from the EPA, there are a couple of corrections to make, and these will be done in the next week. We received an application from the BLM for the natural gas project; the application fee will be \$2,227.00. The town is 644<sup>th</sup> in line with the BLM and this process may take about 2-3 years to complete. Will met with the engineer from WYDOT and they gave the

impression that they will be easy to work with on the project. Mr. Ken Casner's building permit was also discussed during the council meeting.

**Park Board:** Brett Larson, the park board chairman, presented the park board report to the council. Brett thanked the council for the new garbage cans at the park. The park board will store the garbage cans during the winter. The board had a member resign. The board is continuing their plans for the Labor Day event to be held September 6<sup>th</sup>.

**Cemetery Board:** Brett Larson, the cemetery board chairman, present the cemetery board report to the council. Brett let the council know a board member resigned. Mayor Irene appointed Wendy Briggs to the cemetery board to fill the vacant seat.

Angie reported that the museum's story keeper grant has been approved, and we received the funds for the grant on Monday. The CCSD#2 Recreation Board grant contract has been received. Plans for the Pumpkin Patch Fundraiser have begun. Angie thanked the council for monies donated from the town events line item to help purchase the food to be served at the Pumpkin Patch Fundraiser. The sign for the historic Elk Mountain church has arrived.
