CITIZENS ADDRESSING
THE COUNCIL:

Al Santilli addressed the Council with respects and appreciation for Council Member Casner and Council Member Booth that will be leaving office at the end of their term.

REPORTS:

Reports were given by Fire Dept., SCWEMS, Water Dept., Public Works Dept., HCJPB, and Historic Trails RC&D.

Fire Dept.: Chief Sherwood said he would check on the fire hall energy grant that was applied for and see where it is. The bid was advertised in the Rawlins paper for the bucket truck the opening will be at the January 14th Council Meeting. Bob Meyer and Ryan Lewis are taking Fire Fighting 1 training. The department is having their annual chili cook off on December 15th.

SCWEMS: Bill Sherwood told the Council that it has been a slow month for the ambulance service.

Water: Public Works Director reported that everything is about the same at the water treatment plant. He said he pumped for Superintendent Eastman while he was gone. The chlorine system is still showing discrepancies in usage.

Public Works: Public Works Director Larsen told the Council he cleaned the floats at the sewer and they should work better and not get as tangled. He is completing moving the sandbags to the fire hall. The ice rink is about completed. Cm. Casner asked if he could put some dumpsters to replace the 55 gallon barrels the 4-H uses for recycling to keep the cans more contained.

HCJPB: Nothing to report except the next meeting is December 13th in Hanna.

HTRC&D: Clerk Crane reported Louis Espinosa called a teleconference meeting scheduled for December 17th. He is requesting that HTC&D does not dissolve their 501c3 and wants a vote of all the membership.

TREASURER'S REPORT: Treasurer Crane recommended approval of the treasurer's report. **Cm. Hobbs motioned to approve the treasurer's report;** Cm. Jones seconded the motion, Council poll; Cm. Crane told the Council that the new rates for garbage and sewer are being updated by Black Mountain in the system.
